






WELCOME TO CHAMPALAL GROUP





- CHAMPALAL & CO. was founded by business leadership minded Shri Champalalji Parekh. It started with trading in Castor Seeds and Sesame Seeds. It turned out to be a great success with a turnover of Rs. 50 Lac in the year 1975 and after which it never looked back. With foresight and vision of company it formed CHAMPALALGROUP with 11 companies of various diversifications.
- The group diversified into refining salt, manufacturing & exporting castor oil & castor oil
 derivatives, producing plastic products, importing plastic scrap from various parts of the world for
 recycling process, got involved in cargo, importing timber from various countries to name a few.
 The group has grown to a turnover of USD 500 Million in 2019-20 and also group provides
 employment to nearly 2000 people.

OSWAL AGRIMPEX (formerly known as S C Chemicals)

The company is situated in Kandla Special Economic Zone, Gandhidham, Gujarat. We are ISO 9001:2015 Company. Ours is one of the oldest castor oil unit established since 1983. It manufactures Castor Oil and is a Government Recognized Export House which exports BSS Grade (First Special Grade) & Commercial Grade Castor Oil to various countries viz., China, Korea, France, USA, Thailand, Netherlands, Brazil etc. We have exports of 25,000 MTS of castor oil every year.

AGENCIES & CARGO CARE LIMITED:

- Agencies & Cargo Care Limited is public limited company engaged in the business of providing facilities for hiring of storage tanks for all type of edible oils, liquid, including the business of providing facilities of storage services, loading and unloading of cargo by rail. The Company has been operating the facility located at Kandla since last 30 years.
- Agencies & Cargo Care Limited is a Public Limited Company. The company has its presence in the Port industry for the past 30 years. At present there are 36 Storage Tanks having the storage capacity of 80000 KL at Kandla, Gujarat. The company is also providing the transportation of cargo from storage tanks to any where in India by railway as well as road.
- The Company started its operation in February 1979 under partnership. The company was transferred as limited company as Agencies & Cargo Care Limited June 6, 2001.
- The terminal is located at New Kandla with the capacity of 80,000 K.L. (36 Tanks with different capacity) The terminal is spreaded out in 14,000 Sq.Mtrs. of land and is very close to Kandla Port.
- The terminal has 4 no's of Pipelines 8", 10" x 2, & 12" dia meter respectively and the same are connected with Oil Jetties and the pipeline discharge capacity of 8" dia meter is 140 Metric Tonnes per hour, 10" dia meter is 275 Metric Tonnes per hour and 12" dia meter is 380 Metric Tonnes per hour.
- This is the first company in India which has obtained Integrated Management System ISO 9001:2008 from Bureau of Indian Standards and also obtained Environment & Safety certificate 14001:2004 & 18001:2007 from BVQI (Bureau Veritas Certificate (India) Pvt. Ltd.)

• PLASTENE INDIA LIMITED:

- Plastene India Ltd. is a flagship company of the Champalal group based in Gandhidham, Gujarat, India. The company made a humble beginning in year 1998, formerly known as Oswal Agloimpex Private Limited, involved in importing plastic scrap and reprocessing it to manufacture agglomerates which were sold to various plastic manufacturers. We are top 5 plastic manufacturing companies of India. The company Turnover during the financial year 2017-18 is about USD 100 million.
- In year 2005, the company ventured into the manufacturing of woven sacks and woven fabrics at Nani Chirai, Gujarat for servicing domestic salt, cement and fertilizer industry.
- Under the dynamic leadership of Mr. Prakash Parekh (Managing Director), the company gradually expanded its product portfolio and started manufacturing FIBC (Flexible Intermediate Bulk Containers), flexible packaging, tarpaulin, multifilament yarn and masterbatch. As a result, became the world's only company to start up with 21,000 metric ton (mt) annual capacity.
- In year 2007, the name of the company was changed to Plastene India Limited to meditate wider activities of our company. Later in that year, the company opened its second manufacturing unit in Rajpur village, Gujarat, to primarily manufacture woven bags and FIBC. The company was declared as India's best performing mid-size company during 2006-07 by Business World Magazine.
- Looking Ahead: It's where the crystal ball normally comes out and lofty predictions are generally made. At Plastene, however, the future is not what we are going to do, but the company is already doing things which would bear fruit on at a later date.
